**Withdrawal of Investment-linked Riders: IL HealthCare Benefit (Plan Code: U53, U54, U55, U56 & U57) & IL Health Protector (Plan Code: U35, U36, U37, U38)**

***Qingdao Wish You Happy New Year 2009!***

We are pleased to inform that the Company will be launching a new medical rider for ILP called **IL Smart Medic**. With the introduction of IL Smart Medic, IL HealthCare Benefits (IL-HCB) & IL Health Protector (IL-HP) will be withdrawn from New Business effective **28 February 2009 (Saturday)**. In other words, the Company will not accept new proposal of these two riders (IL-HCB and IL-HP) on or after **28 February 2009**.

In view of the request and feedback from our field force, the Company will continue to allow the following arrangements to facilitate the needs of the existing Policy Owner to either:

1. Convert existing HealthCare Benefit (IL-HCB) to Health Protector (IL-HP) for Child Policy\*
2. Upgrade the existing IL Health Protector (IL-HP)\*\*
3. Upgrade the existing IL HealthCare Benefit (IL-HCB)\*\*

*\*Note: Kindly refer to the earlier circular issued dated 3 September 2008 (CAD/0621/Sept2008), entitled "Special Waiver of Waiting Period for Medical rider" for term and condition.*

The above-mentioned arrangements will be made available until 31 July 2009 (Friday). Hence, Policy Owner can no longer make any amendment to their existing IL HealthCare Benefits (IL-HCB) and IL Health Protector (IL-HP) after 31 July 2009.
