Minutes of Triennial General Meeting held on 21st March 2008 at Meeting Room 1, 1st Floor, Heritage Hotel, Jalan Raja Di Hilir, Ipoh, Perak Darul Ridzuan at 2.00pm

The Meeting was called to order at 2.30pm with an attendance of 26 members.

1. Welcoming Speech by Branch Chairman

The Chairman welcome members for their presence and was grateful that the Secretary General, Mr K C Ng and Treasurer General, Mr Michael Chin were with us despite their busy schedule. He urged the members to be united under the umbrella of the Association to face the challenges ahead.

The Chairman also took the opportunity to thank fellow committee members for their co operations and contributions during the tenure.

2. Address by GELFAAM Exco Member

Secretary General, Mr K C Ng welcomed all members to the TGM. However, he was disappointed with the turnout and hope that more members will participate in our future meetings as it demonstrates their support for the Association.

He stressed the importance of the Association which existed with the objective of safeguarding the members' benefits. As the agency force is actually a businessman of our own rights, we should take care of our own rice bowl.

Some changes introduced by the Management had also affected the field force, viz. Supremacy points system, launching of Great Universal Life insurance with lower commission rate etc.

He felt that members should response towards these changes and complain direct to Branch Management during meetings or product launching. With the wind of change following the 12th General Election, all members should be proactive to give feedback and support to the Association.

With the imminent deregulations under the Financial Sector Master Plan in 2010, where the capping for commission will be removed, the Association has to be prepared for this upcoming change.

3. To confirm Minutes of Triennial General Meeting held on 25th March 2005

The Minutes was unanimously adopted upon the proposal made by Chinaya a/l Ganggaya and seconded by Krishnan N K Nair.

4. Matters arising from the Minutes

There was no outstanding matter arising from the Minutes.

5. To receive Hon. Secretary Report

The Hon. Secretary report was made available to the members and it was unanimously adopted.

6. To receive Hon. Treasurer Report

The Hon. Treasurer report for year 2005, 2006 and 2007 were made available to the members. It was proposed to be adopted by Liew Thiam Seong and seconded by Robin Toon Sau Choo.

7. Any other matter

Chinaya a/l Ganggaya voiced his concern about the outstanding and long standing issues as highlighted in the Hon. Secretary report. He disagreed with the Secretary General contention that agents should complain to the Company directly. He viewed that the Association should play its role to defend our rights, and if members have to complain to the Management on their own, then there won't be a need to have the Association.

Teh Hock Ke opined that the RM25 annual subscription paid to LIAM was unnecessary as LIAM is a body representing the insurer. Field force should not be compelled to contribute towards association representing insurance companies.

Chinaya a/l Ganggaya commented that the Branch Management should decorate the office on every festivals to instill some air of festivities. He also hoped that the Association will pursue with the Company on the presentation of Long Service Awards to members of the field force to be carried out with sincerity and dignity.

8. To officially dissolve the Branch Committee and appoint an Election Chairman to conduct election of Office Bearers for term 2008-2011

The Secretary General officially declared that the Branch Committee is dissolved and he was unanimously appointed as Election Chairman.




